

# Privacy Policy

This Privacy Policy ("Policy") applies to [www.aprilsmithfineart.com](http://www.aprilsmithfineart.com), and April Smith Fine Art ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include [www.aprilsmithfineart.com](http://www.aprilsmithfineart.com). The Company's website is an online art gallery and e-commerce site. By using the Company website, you consent to the data practices described in this statement.

## Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. ## Sharing Information with Third Parties

## Tracking User Behavior

- Engage in public or peer-reviewed scientific, historical, or statistical research in the public in
- Enable solely internal uses that are reasonably aligned with your expectations based on your
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with
